2.2 General Admission & Registration Policy

<u>PURPOSE(S):</u>

Little Haven Nursery welcomes families and children from all nationalities, we operate an inclusion and equality policy and ensure that all children have access to nursery places and services irrespective of their gender, race, disability, religion or belief or sexual orientation of parents.

DESCRIPTION(S):

Little Haven Nursery accept children from age 2 months to 4 years, Prior to a child attending the Nursery, parents must complete and sign application contract and registration form. These forms provide the Nursery with personal details relating to the child. For example, name, date of birth, address, emergency contact details, parental responsibilities, dietary requirements, collection arrangements, fees and sessions, contact details for parents, doctor's contact details, health visitor contact details, allergies, vaccination, parental consent of social media and medical attention as needed.

Documents required before your child's first day:

- Application and Registration Form
- Medical and Consent Form
- Allergy Alert Form (if applicable)
- 6 Passport Photos
- Copy of Child's Passport including Visa page + Emirate ID
- Copy of Parent's Passport including Visa page + Emirate ID
- Copy Immunization Records
- Copy of Birth Certificate
- Copy of Medical Card / Emirates ID Card

Disability and Special Educational Needs:
